In consideration of the agreement herein, **Hagstrom LLC D.B.A Hunters General Store** does lease to the undersigned (hereafter referred to as the LESSEE) the craft and equipment described herein. LESSEE agrees said craft will not be occupied by a greater number of persons than is shown in this agreement.

The lessee certifies that he/she has examined the craft and equipment and finds it acceptable and suitable for the purpose for which it is leased. That he/she will operate and maintain both the craft and equipment in a safe, dependable condition in accordance with all safety rules and regulations as provided or on the craft while in his/her custody, and further certifies that he/she has read and understands said rules and regulations. Any damages, not preexisting, will be charged accordingly to the lessee. If rental craft is not returned in the condition it is sent out in, additional damage/cleaning fees will apply.

LESSEE AGREES TO REPORT ANY ACCIDENT, MALFUNCTION OR BREAKDOWN OF RENTAL CRAFT TO **Hagstrom LLC D.B.A Hunters General Store** IMMEDIATELY. CONTINUED USE OF IT SHALL BE ENTIRELY AT THE LESSEE'S RISK AND THUS LESSEE ASSUMES ALL LIABILITIES OF INJURY AND DAMAGE TO ALL PERSONS AND PROPERTY THAT MAY BECOME INVOLVED BY ITS CONTINUED USE.

LESSEE agrees not to use, nor permit the use: (A) of the rental craft for any unlawful purpose; (B) of the rental craft in a careless or negligent manner; (C) of the rental craft while under the influence of liquor and/or narcotics; (D) of the rental craft by any other person not the signatory of this agreement or not equally qualified, (E) No animals (dogs, cats, Etc.) permitted on rental craft, there will be an additional penalty fee applied.

Lessee acknowledges his/her responsibility for the safe and proper operation of the craft; and for the safety and welfare of other boaters and persons. It is **AGREED AND UNDERSTOOD BY LESSEE** that **Hagstrom LLC D.B.A Hunters General Store** shall not be held liable for damages, inconvenience of time lost caused by accident, breakdown or malfunction of the rental craft. LESSEE FURTHER AGREES to indemnify and hold harmless **Hagstrom LLC D.B.A Hunters General Store** from, and against any and all claims for loss of or damage to property or injury to persons (including death) resulting through the use, operation or possession of said rental craft. LESSEE further agrees to hold **Hagstrom LLC D.B.A Hunters General Store** harmless should loss or damages occur to any of the LESSEE'S personal property while carried in, or on, the rental craft, including loss or damage caused by fire, water, theft or any other cause whatsoever.

Lessee expressly agrees to indemnify and hold **Hagstrom LLC D.B.A Hunters General Store** harmless of, from and against any and all loss, costs, damages, attorney fees and/or liability in connection with the enforcing of this agreement by **Hagstrom LLC D.B.A Hunters General Store**, including expenses incurred in collection or attempt to collect delinquent rent and in the event of suit by **Hagstrom LLC D.B.A Hunters General Store** to recover possession and said rented property and/or to enforce any of the terms., conditions and/or provisions thereof, it is understood and agreed that Venue of any action hereunder shall be in the county and state of Hunter's General Store D.B.A Bear Country. This agreement shall be governed by the laws of the state of **Hagstrom LLC D.B.A Hunters General Store**.
